Big Ten/MAC Replay Test #2

1. A 3rd and 7 on B28. QBA1's pass is intercepted by B31 at the B15 and he returns to it to the A48 where he is tackled by the facemask by A88. During the return B77 held A65 at the B25. Replays show that the ball hit the ground before B31 gained firm control of it.

2. A 2nd and 10 on B47. Back A2 takes a handoff and runs down the right sideline towards the goal line. He is ruled out of bounds at the B12 but continues to run to the end zone. Replays clearly show that he did not step out of bounds at the 12.

3. A 2nd and 8 on A22. Back A2 takes a handoff and runs to the A31 where he is hit and loses the ball. B37 picks up the loose ball and returns it for a TD. Replays show that A2 still had firm control of the ball when his left elbow hit the ground.

4. A 3rd and 20 on A10. QBA1 completes a pass near the sideline to eligible receiver A80 at the A23. A80 appeared to be bobbling the ball as he crossed the sideline but it is not definitive either way. A lines up in a punting formation.

5. A 1st and 10 on A40. QBA1's pass to eligible receiver A80 is ruled complete near the sideline at the B37. Tackle A77 held B98 at the A36. Replays show that after A80 gained firm control of the ball his left foot stepped out of bounds.

6. A 1st and 10 on A32. QBA1's low pass to eligible receiver A89 at the B44-yard line is ruled incomplete. During the play B91 was offside and after the play B37 taunted A89. Replays show that A89 gained firm control of the ball and it did not touch the ground during the process of the catch.

7. A 3rd and 7 on A43. Back A30 catches a screen pass and runs to the B49 where he is hit and loses the ball. A87 clearly recovers the loose ball at the A49. The officials rule that A30 was down before he lost the ball and spot it at the B49. Replays show that the ball came loose before A30 was down.

8. A 3rd and 10 on A27. QBA1's pass is intercepted by B36 at the A42. B36 returns it to the A20 where he attempts to throw a backward pass to B41. The ball hits the ground at the A18 and is recovered by A77. The officials on the field rule the pass backward and give possession back to A.

9. A 3rd and 10 on B37. QBA1 drops back to the B44 and while still in the pocket he throws the ball away to avoid being sacked. The referee throws his flag for intentional grounding. After the penalty the ball is spotted at the B44 and it remains 3rd down.

10. A 4th and 3 on A41. Team B is confused before the snap and B56 tries to get to his bench area before the snap. He gets about 2 yards from the sideline when the ball is snapped. B23 fields the punt at the B17 and returns it to the B23. The line judge threw his flag for illegal substitution. Replays show that B56 was the 11th defensive player on the field.

11. A 4th and Goal on B1. Back A2 takes a handoff and gets hit right at the goal line. The ball comes loose and it goes into a pile of players in the EZ. The officials rule the ball broke the plane of the goal line before it came loose. Replays show that the ball was loose at the 1/2-yard line but there is no shot that shows who recovered it in the EZ.

12. A 4th and 7 on A48. Team A's punt hits the ground at the B10 and then grazes the left leg of B21 who is trying to get out of the way of the ball. The ball rolls into the EZ where it is downed by B37. The officials rule touchback.

13. A 3rd and 4 on B25. Back A2 catches a screen pass and runs to the B22 where he is hit and the ball comes loose. B56 attempts to recover the loose ball at the B18 but muffs it to the B15 where B98 recovers it near the sideline. The officials rule fumble recovered by the defense. Replays show that it was a fumble but B98's right foot was touching the sideline when he recovered the ball.

14. On a two-point try attempt Back A2 takes a handoff and runs towards the goal line but he gets hit at the 1-yard line and fumbles. A77 recovers the loose ball in the EZ. Officials rule the try attempt good.

15. A 3rd and 12 on A25. QBA1's pass is intercepted at the A48 by B37 who returns it to the A30 where he is hit and fumbles. B77 illegally bats the ball at the A30 to the A22 where it is recovered by B54. There are no flags on the play.

16. A 4th and 10 on A45. A's punt hits the ground at the B15 where it hits the left arm of A19 and then bounces towards the EZ. A39 bats the ball near the goal line to the B3 where it is downed by A45. The officials spot the ball at the B3-yard line. Replays show that the ball did not break the plane of the goal line before A39 batted it.

17. With 4:07 left in the 4th Qtr Team A is behind 42-10. On 2nd and 10 from the A32 QBA1's pass is ruled intercepted by B37 near the sideline at the A48. Replays show that B37 never had control of the ball as he crossed the sideline.

18. A 4th and 7 on B27. Team A's field goal attempt is ruled no good. Replays show that the ball crossed over the top of the left upright. Team A coach attempts to challenge the ruling.

19. A 2nd and 10 on B37. Back A2 takes a handoff and runs to the B30 near the sideline where he is hit and loses the ball. B55 recovers the ball at the B34 but the officials rule that he was out of bounds. Team B challenges that B55 recovered the loose ball inbounds. Replays show that B55's right foot was touching the sideline when he recovered the ball and also that A2's left knee was down before he fumbled.

20. A 2nd and 1 on B23. QBA1's pass is intercepted by B21 near B's goal line. He attempts to run it out but while still in the EZ he gets hit and fumbles the ball which rolls out of bounds at the B4. Officials rule touchback. Replays show that when B21 first possessed the ball it was breaking the plane of the goal line.

21. A 3rd and 10 on A20. QBA1's pass to end A88 is ruled complete near the sideline at the A34. Replays show that as A88 was going to the ground to make the catch he got one foot down in bounds and when he hit the ground out of bounds he momentarily lost control of the ball, but regained it before the ball hit the ground.

22. A 2nd and 5 on B34. QBA1's pass is caught by eligible receiver A80 at the B20 near the sideline and advanced for a TD. The Side Judge throws his flag for illegal touching; ruling that A80 stepped out of bounds at the B25 before coming back in to catch the pass. Replays show that A80 did not step out of bounds.

23. A 2nd and 1 on A35. End A84 catches a pass at the A48 and is hit immediately causing the ball to come loose. B37 falls on the loose ball at the 50 in the continuing action after the play. The Back Judge comes in and rules the pass incomplete. Replays show that A84 got control of the ball and two feet clearly down before he lost it.

24. A 4th and 7 on A31. After A's punt crosses the neutral zone B37 holds A57 at the A33. B21 fields the punt at the B25 and returns it to the B30. After enforcing the foul the officials spot the ball at the B15 1st and 10 for B.

25. A 3rd and Goal on B8. QBA1's pass to eligible receiver A87 is ruled incomplete in the EZ. Replays show that A87 got control of the ball with two feet down and then was hit by a defender causing him to go to the ground where he lost the ball.
